CONSTRUCTION OF RELIGIOUS BLASPHEMY REPORTING

(Framing Analysis of The Case of Muhammad Kece at detik.com and republika.co.id)

Abstract

Blasphemy cases have occurred several times in Indonesia. Recently, a blasphemy case emerged that caused a stir and was criticized by several parties. The case of blasphemy that occurred in 2021 was carried out by a YouTuber named Muhammad Kece. Various reports began to be published by the media. This article discusses the construction of blasphemy reporting by Muhammad Kece on the online media Detik.com and Republika.co.id. This study uses a descriptive qualitative approach by observing the news text. The results show that Detik.com and Republika.co.id is less balanced in reporting this case. However, Detik.com from the beginning did not judge Muhammad Kece as a suspect before there was a decision from the authorities. While Republika.co.id tends to call for the voice of Muslims in its reporting and considers that Muhammad Kece is guilty of blasphemy cases. But in the end, the two media agreed that Muhammad Kece was named a suspect and detained.

View history cases of blasphemy in Indonesia, have happened before Indonesia was born as a nation-state. Based on Juma's research one who studies the historicity of blasphemy that occurred in Indonesia, blasphemy Religion had occurred before independence, namely in 1900-1940. Marked by the emergence of a blasphemy social movement that background three newspapers; Djawi Hisworo in 1918, Soeara Oemoem in 1930, and Madjalah Bangoen in 1973 (Juma', 2018)

The case of blasphemy in Indonesia is still a big issue, this is because the Indonesian people are known as a religious nation. Moreover, blasphemy against the main religion, namely Islam (Fahmi, 2018). Blasphemy cases have occurred several times in Indonesia. Among them were carried out by Basuki Tjahaja Purnama in 2017 and Sukmawati Soekarnoputri in 2019 (Khotob dan Wardana, 2021). Throughout 2020, these cases were spread across 22 provinces in Indonesia. Provinces with the most cases were East Java and North Sumatra with 8 cases. Then, followed by West Java with 7 cases and South Sulawesi, DKI Jakarta, and North Maluku with 6 cases (Asfinawati, 2020).

In May 2021, a blasphemy case perpetrated by Muhammad Kece emerged which seized the public's attention. Muhammad Kece is known to be Muslim and his ID card, but he was baptized and converted to Christianity in 2014. He has been a Youtuber since July 17, 2020 Khotob dan Wardana, 2021). Muhammad Kece caused a stir after his video was claimed to insult Islam. In his videos, Muhammad Kece broadcasts live individually, but sometimes contains a discussion forum with several other people. The discussion in his video content often interprets the verses of the Qur'an. In the live broadcast on June 30, 2021, entitled "The Prophet Who Was Surrounded by Jinn", which was watched 8,321 times, this is one of the videos that are said to trigger allegations of blasphemy by Muslims in Indonesia. In his video, Muhammad Kece says:

"Muhammad SAW was friends with the jinn, close to the jinn. Jin is a kind of nation with demons. Want to be friends with the devil?"

Then on the 21st of August 2021 there is a cool video entitled "Muhammad Kece criticized MUI". This video has been viewed 38,165 thousand times. This video too used evidence that Kece blasphemed religion. The sentence that trigger it is "Good Afternoon, Kind Regards, Assalamu'alaikum Warahmatu Jesus Wabarakatuh, Thank God Jesus Hirobbil Alamin...", since At that time someone reported Muhammad Kece with a case of blasphemy religion.

With these words, Kece certainly reaped various responses, including criticism and pressure from several parties. Criticisms and pressures include MUI (Indonesian Ulama Indonesia) and PA 212. MUI condemned Kece's video, then PA 212 urged to immediately make an arrest, if within 3x24 hours it is not fulfilled, PA 212 threatens to hold a demonstration by taking to the streets (Arhamni, 2021).

In addition to being caught in a blasphemy case, he is also considered to have violated article 28 paragraph 2 article 45 in Law no. 11/2009 which was amended by Law no. 19/2016 on Information and Electronic Transactions (ITE). Kece is considered to have made a video containing religious blasphemy that can cause hatred and hostility to SARA (Ethnicity, Religion, Race, and Intergroup) (Khotob dan Wardana, 2021)

Through online media videos and news circulated quickly. Since Muhammad Kece's video appeared on June 19, 2021, and August 21, 2021, then the date August 222021, there has been news regarding his blasphemy. Various media in Indonesia certainly highlight this blasphemy news, including Detik.com and Republika.co.id. The reason for choosing the two media is because they have different ideologies and both are included in large national-scale online media (Nisa, 2020).

Detik.com is digital online media that updates and provides a lot of news selection, its presence as a capable secular media provide a variety of news type. Its vision is to make Detik.com the first place visited to get content for the Indonesian people, good in mobile and internet forms. Whereas Republika.co.id is a media that was born from the community Muslims, which aims to channel the aspirations of the people and foster a plurality of information in society (Nisa, 2020)

This study wants to see how this blasphemy case was constructed by the mass media Detik.com and Republika.co.id. as well as to find out how the differences and similarities of the two media in constructing it.

Research methods

This research is qualitative research using a media text analysis approach, namely framing analysis from Robert N. Entman which focuses on how to frame a news text. In this study, the analysis focuses on the four elements of Entman's framing of news texts to find out the frames used in news texts at Detik.com and Republika.co.id. The object of this research is news text on Detik.com and Republika.co.id in the period 22-25 August 2021, where there are four news stories from each media, so the total number analyzed is eight news texts. In the period date August 22-25, 2021, there is 51 total news published by Detik.com, while on Republika.co.id there is 28 news.

The reason for choosing the news according to the date above is because the selected news text certainly has the same theme, so the difference in news packaging will be more prominent. In addition, it is also caused by the selected news text that represents a series of events that occurred during the blasphemy case of Muhammad Kece, starting from the emergence of cases, reporting, arrests, and naming of suspects.

Results and Discussion

In the use of news titles, Detik.com uses an exclamation mark (!) at the end of the sentence. This sign is usually used to emphasize, describe the seriousness of something, and is often used to describe words or sentences that contain strong emotions (Tim Redaksi BPIP, 2020). The two media have different sources. Detik.com has clear sources, both names and institutions involved, the use of news images which are photos of the source, Helmy, supports news framing that news content is information obtained from sources directly.

While Republika.co.id uses a picture in the form of an illustration with the words "BLADE OF RELIGION", where the words "blasphemy" is red and "religion" are white, and the background of the image is black with a faint image of a human skull behind it.

Black represents a soft or dark impression, red is often depicted in terms of being active, energetic, and full of vitality, while white represents purity, purity, lightness, and refinement. The symbol of the human skull is used as an image that has contradictory meanings, between symbols of courage, religiosity, or death (Pujiyanto, 2011). Overall, the illustrations on Republika.co.id news illustrate that blasphemy against religion is something that is considered dark and is a crime that has a major impact on human life.

Define the problem on Detik.com and wrote PBNU's response to Muhammad Kece's actions. This can be seen in the fragment of the news text "The big board of Nahdlatul Ulama (PBNU) assessed that the content of YouTuber Muhammad Kece's lecture fulfilled the element of hate speech. Therefore, PBNU urges the police to take action against Muhammad Kece." (Rahayu, 2021)

While Defining the problem on Republika.co.id through criminal law expert Suparji Ahmad explained that Muhammad Kece's words led to blasphemy. This can be seen in the fragment of the news text "Criminal Law Expert, Suparji Ahmad, said that YouTuber Muhammad Kece (MK)'s remarks that offended the Prophet Muhammad led to blasphemy. According to him, the Court's actions have fulfilled elements 156a of the Criminal Code." (Permana, 2021)

There are differences in defining problem elements in both media. Detik.com uses the word "assess" which means to estimate and consider something that is observed (Afifah, 2016). In the excerpt of the news text, Detik.com still estimates that Muhammad Kece's words are hate speech, then Republika.co.id firmly says that Muhammad Kece's words lead to blasphemy.

Diagnose cause on Detik.com, he saw that the problem had arisen because Muhammad Kece's statement had fulfilled hate speech

against a religion. This can be seen in the fragment of the news text "In connection with the circulation of a statement from someone named Muhammad Kece who in our view this statement has fulfilled the element of hate speech or hate speech against a religion."

Diagnose cause on Republika.co.id news, the problems that arise occur because the elements contained in law have been fulfilled by Kece. This can be seen in the fragment of the news text. "He explained that the element of 'whoever' is also fulfilled because the Constitutional Court is a legal subject who can be held accountable for his actions. While the element of 'in public' is fulfilled because the person concerned uploaded the video on the youtube channel."

Media agenda setting is a theory in which what is important to the media is what is important to the public. So that the media present issues based on what they consider important, this is media policy (Agustina & Irwansyah, 2017). Today the media enable the main dissemination mechanism of mass communication. The media enable massive information dissemination mechanisms and facilitate the construction of social consensus (Firmonasari, 2021). In this case, Detik.com raises the issue of hate speech, while Republika.co.id considers it blasphemy.

Making a moral judgment on Detik.com used the opinion of PBNU, which considered that Muhammad Kece's words could disrupt religious harmony. When the secretary general of PBNU, Helmy Faushal Zaini give statement to reporter that can be seen in the text of the news "So we convey that we strongly condemn Muhammad Kece's strong statement because this can disrupt the religious harmony that has been built so far which is incredibly beautiful".

Make a moral judgment on Republika.co.id he described there was no opportunity or place for people who insulted religion. This can be seen in the fragment of the news text "Because there is no room for blasphemers of religion in Indonesia. Police should take firm and measured action against cases like this." The two media have different moral judgments. The news value of conflict/controversy is that the events reported contain elements of conflict that have more

potential to be reported. Religious diversity in Indonesia cannot be separated from inter-religious conflicts by individuals or groups of people (Agustina & Irwansyah, 2017).

Treatment recommendations Detik.com emphasizes problemsolving using PBNU arguments, to always liven up the spirit of religious moderation. This can be seen in the fragment of the news text "Let us always live the spirit of religious moderation..."

At Republika.co.id, a treatment recommendation offers the community not to act alone, then hand over this problem to the party in charge. This is contained in the news text, "Suparji also asked the public to refrain and surrender fully to law enforcement. He advised, there should be no vigilante action from the community."

Treatment recommendations on the two different media. Detik.com uses the word "let's go", which means to invite readers or audiences. While Republika.co.id uses the word "don't" which means to prohibit readers or the public. These words have different meanings. So, it can be interpreted that Detik.com uses a friendlier word than Republika.co.id

Mass media, including Detik.com and Republika.co.id have a role and impact on society. One of the positive impacts is as a messenger to the public to be wise in responding to issues about Muhammad Kece (Agustina & Irwansyah, 2017). Religious fanaticism and deep belief in each religion's adherents in responding to cases as well as religious discrimination and harassment that occur in the media are also the cause of divisions between religious communities (Munardi, 2021)

Detik.com uses the word "alleged" in the title of the news. The word allegation is generally used to avoid defaming or the impression of accusing, the choice of this word aims to prevent writing from accusing or judging something (Nurhadi et al., 2019). This shows that Detik.com holds value in its company, namely being independent in reporting.

The use of images is used to support news framing. Detik.com uses a clearer image, because the image is a photo of the police as the source, and the microphone points to Agus Andrianto as the source. Meanwhile, Republika.co.id uses an image of a group of several police officers and makes it look out of focus.

Treatment recommendati ons

The police have carried out cyber patrols to process reports against Muhammad Kece, as well as to unify all reports in the Criminal Investigation Department

The National Police Criminal Investigation Unit is following up on incoming reports by withdrawing reports of alleged blasphemy carried out by Kece in the regions to be processed at the National Police Headquarters and video tracking is carried out using joint cyber patrols.

Define the problem on Detik.com it is described that many parties have who have reported Kece to the police. This can be seen in the text of the news "Youtuber Muhammad Kece was reported by many parties to the police on suspicion of insulting Islam..."(Dirgantara, 2021b).

Define problem Republika.co.id describes the number of reports, namely four reports that are currently entering the investigation stage. This information was obtained by Republika.co.id from direct meetings. This can be seen in the fragment of the news text "Bareskrim processed four reports related to the alleged blasphemy of Islam by YouTuber Muhammad Kece." (Putra, 2021)

Both news has different Define problem elements, Detik.com uses the word "many", in KBBI it means large in number, not small. Meanwhile, Republika.co.id clearly stated that there were four incoming reports. This shows that the facts presented by Republika.co.id are more accurate.

Diagnosis caused Detik.com to say that Kece was reported to the police for having offended the religion of Islam through several distorted and distorted words. This can be seen in the text of the news "Previously, YouTuber Muhammad Kece went viral on social media. Some of his remarks were controversial and led to various criticisms." Diagnose cause on Republika.co.id, it was described that Kece's controversial video content caused him to be reported by four

parties to the police. This can be seen in the snippet of the news text "Kece became controversial after uploading content that blasphemed Islam, such as changing greetings."

The two media have different diagnostic cause elements. Detik.com saw the case start because Kece's words were changed and distorted. Meanwhile, Republika.co.id sees the case as starting because Kece's content invites controversy, not just words in the video. However, both news stories have the same news value, which contains conflict/controversy values.

Make a moral judgment on Detik.com news, Kece is considered to have insulted Islam by distorting a few sentences. This can be seen in the fragment of the news text, "Muhammad Kece is said to have insulted Islam. One of the things he digresses about is greetings..."

Make a moral judgment on Republika. co. id, Muhammad Kece became a controversy because his content defamed Islam. This can be seen in the snippet of the news text, "Kece became controversial after uploading content that defamed Islam, such as changing greetings, not just greetings."

The elements of making moral judgments in the two media are different. Detik.com gives a moral assessment that Kece is still considered to have insulted religion, because the news quote uses the word "judged", the same as the use of the word "judge" in his first news story. While Republika.co.id gives a moral choice that Kece is the maker of the controversy over the video he uploaded. Republika.co.id uses the word "to be", in the KBBI it means to be appointed, elected, or as.

Blasphemy is defined as certain words or actions that are defiling or degrading (Fauziah, 2018). In the Detik.com news text fragment above, it is stated that Kece's words have offended Muslims, and made MUI offended and angry, this was used as a moral choice made by Detik.com. Meanwhile, Republika.co.id did the same but did not mention any parties who felt offended or angry with the Muhammad Kece content.

Treatment recommendations from Detik.com emphasized the role of the police in responding to the alleged blasphemy case of

Muhammad Kece, namely carrying out cyber patrols and all reports being combined. This can be seen in the news text, "According to him, the police also conduct cyber patrols. Agus explained that all reports against Muhammad Kece would be merged."

Republika.co.id offers a treatment recommendation for a follow-up from the Criminal Investigation Department to withdraw reports in the area so that they can be carried out centrally and to track down police officers who carry out cyber patrols. This can be seen in the news text, "In following up on the report, his party mobilized the available resources. Then, track the videos that are going viral in the community, including through cyber patrols."

In the treatment recommendation element, the two news stories have different framing. Detik.com framed that the police carried out cyber patrols to process incoming reports, while Republika.co.id framed that Bareskrim conducted cyber patrols to track down Muhammad Kece's video. Republika.co.id defines more advanced Bareskrim steps than Detik.com in responding to the Muhammad Kece case.

Based on the treatment recommendations for the two media above, the audience will feel the image that is constructed in the news. News construction is used to find out what frameworks make up a news story (Nur'aini Fauziah, 2018). The image to be shown is the efforts of the police to handle this alleged blasphemy case.

Both of medias use the word "buru", which KBII has sought to pursue. The use of this word likens that the search for Muhammad Kece is the same as hunting animals or animals in the forest. Detik.com uses a picture of Muhammad Kece with the words "KECE IS LOOKING FOR POLICE", using this image will make it clear whom Kece is currently looking for by the police. While Republika.co.id uses the same illustration in news 1. With this, Republika.co.id still sees this as an act of crime against Islam.

Define the problem Detik.com's report described the increase in the status of Muhammad Kece's case to the investigation stage. This can be seen in the fragment of the news text "The National Police Criminal Investigation Agency has raised the status of the alleged blasphemy case by YouTuber Muhammad Kece to the investigation. Now the police are looking for Muhammad Kece who is suspected of insulting Islam." (Dirgantara, 2021a).

Define the problem that Republika.co.id describes in this report the increase in the status of the case to the investigation stage, Republika.co.id also explained that the increase in status has not been accompanied by Kece's status as a suspect. This can be seen in the snippet of the news text "Bareskrim Polri Headquarters raises the status of the investigation to the level of investigation related to cases of harassment and blasphemy of Islam carried out by YouTuber Muhammad Kece. The increase in the legal process, however, has not been accompanied by the determination of the suspect." (Indira Rezikari, 2021)

Both of medias have different Define problem elements. Detik.com gives one issue that the increase in the status of the Kece case is due to allegations of blasphemy, while Republika.co.id has two issues, namely the increase in the status of the Kece case due to alleged harassment and blasphemy of Islam. The two media have a different number of issues because each media has a different

prominence news value, where an event is seen from the meaning of its importance so that news is considered important to be reported (Eriyanto, 2002).

Detik.com illustrates that the Muhammad Kece case is a criminal case in general, while Republika.co.id describes this case as a criminal act as well as a crime against Islam. Using the word "harassment", which in the KBBI has the meaning of a process, an act, or a way of harassing. Republika.co.id explicitly constructs the issue after all contradicts its ideology, namely Islamic ideology because it was born from a National newspaper with Islamic interests. As a medium that carries this ideology, a case of blasphemy against Islam is seen as a crime (Fathaniyah, 2018).

Diagnose cause Detik.com described that sufficient evidence was found to be able to escalate the case from the investigation stage to the investigation stage. In this case, Detik.com uses Ahmad Ramadhan as the resource person whom he met directly. This can be seen in the fragment of the news text "Investigators have found sufficient initial evidence so that investigators escalate this case from investigation to investigation."

Diagnose cause to Republika.co.id through Ahmad's statement, he explained that during the investigation process, it had been based on the examination of several parties and had obtained evidence. This can be seen in the fragment of the news text "Ahmad explained, the investigator, during the investigation, had examined several parties, and obtained preliminary evidence ...". In addition to using the evidence obtained, Republika.co.id through Ahmad also added that there were several experts assigned for further examination. In this case, it is explained that there are experts involved. This can be seen in the fragment of the news text "Investigators have examined the reported, also examined expert witnesses, including IT experts, Indonesian language experts, and religious law experts, said Ahmad."

The body is the middle part of the news and is a continuation of the lead. Fact citations are mentioned in this section (Muslimin, 2021). At Detik.com the facts mentioned as sufficient evidence to

raise the status of the case are statements from experts and instructions in the form of evidence posted by Muhammad Kece. Meanwhile, Republika.co.id mentions more complete facts regarding the evidence deemed sufficient to raise the status of the case, where the expert mentioned in the news text quoted above. The two media have different completeness of facts.

Make moral judgment told Detik.com through a resource person, Ramadhan said that M Kece's video has the potential to divide society. This can be seen in the fragment of the news text "Video (MK) has the potential to be divisive. Then the analysis is carried out, verification is carried out for takedown..."

Making a moral judgment on Republika.co.id through his editorial sentence, he considered that Kece's videos had sparked public anger because the videos contained lectures that were considered insulting to Islamic teachings. This can be seen in the text of the news "YouTube account with the name M Kece, which invites public anger. The uploaded video equates the lectures accused of blaspheming the teachings of the Islamic religion."

The two media have different elements of making moral judgments, but they are still in one direction. Namely, Muhammad Kece's videos harm some viewers or the public, because the media has an important role in social life.

Social media supports social interaction and is a medium that allows interactive communication. Video-sharing application is one the most effective applications for disseminating events and information, one of which is youtube. With easy access, of course, the impact can be negative as well as positive (Tongkotow Liedfray, Fonny J. Waani, 2022).

Detik.com assesses that Muhammad Kece's video has the potential to cause chaos and divide the community, where the community referred to here is the community in general. However, Republika.co.id considers that M's video has invited public anger, the public referred to here are mostly Muslims. Both have negative ratings for Kece's video uploads.

Treatment recommendations Detik.com in this report is an affirmation that Kece's videos will be analyzed and verified, then taken down by the Ministry of Communication and Information as the authorized party. This can be seen in the fragment of the news text, "Then an analysis and verification are carried out to carry out a takedown, which is carried out by the Ministry of Communication and Informatics," added Ramadhan.

Treatment recommendations that Republika. coid offers in this report that the investigation is still ongoing and Kece is still being searched. In this case, through information from the source (Ahmad), Kece has not been named a suspect. This can be seen in the fragment of the news text "Currently Polri investigators are still searching for the reported person (M Kece). And the status in question has not been suspected. Still reported, explained Ahmad."

Detik.com directs the reader that there are two ways to solve Kece's case, namely analyzing the video and searching for it. Meanwhile, Republika.co.id emphasized to the readers one of the police's efforts, namely to search for Muhammad Kece.

In the title element above, Detik.com provides an explains in its title that Muhammad Kece is a suspect because it is related to the

ITE Law and Religious Blasphemy, while Republika.co.id only explains that Kece was sentenced to six years without an explanation of the reasons behind his sentence. Detik.com uses images of two figures, namely the Police as the enforcer and Kece as the suspect, with the words "DIJERAT PASAL BERLAPIS" supporting the news framing that the police's efforts have succeeded in arresting Kece. While Republika.co.id uses a picture of Muhammad Kece showing a book, this shows that Republika.co.id considers Kece personally as a perpetrator of religious blasphemy.

Define problem Detik.com described the incident that occurred as the stipulation of Kece as a suspect for alleged blasphemy with a penalty of 6 years in prison. This can be seen in the text of the news "Youtuber Muhammad Kece is a suspect in the alleged blasphemy of religion and/or related hate speech as regulated in the ITE Law. Muhammad Kece faces 6 years in prison" (Dirgantara, 2021c)

Define problem on Republika.co.id it was described that the Bareskrim Polri had arrested Kece in Bali and was threatened with a sentence of up to 6 years in prison. This can be seen in the fragment of the news text "Bareskrim Polri has arrested YouTuber Muhammad Kece in Bali on suspicion of blasphemy." (Raharjo, 2021)

Both of media have different Define problem elements. Detik.com shows that YouTuber Muhammad Kece is a suspect, while Republika.co.id highlights the impression that the Criminal Investigation Department has succeeded in arresting Kece as a suspect.

Diagnose cause on Republika.co.id is described as an explanation of the articles related to the Muhammad Kece case, this was done on purpose. This can be seen in the fragment of the news text "Rusdi said investigators suspected Muhammad Kece with article 28 paragraph 2 junction article 45a paragraph 2 of Law No.19/2016 concerning Information and Electronic Transactions (ITE) and/or article 156A of the Criminal Code."

Cause diagnosis on Republika.co.id described that the Criminal Investigation Police suspect Muhammad Kece on suspicion of blasphemy and was threatened with a sentence of up to 6 years in prison. This can be seen in the fragment of the news text, "Rusdi continued, in this case, the investigator has attached an article on

alleged hate speech based on SARA according to the ITE Law to blasphemy."

The two media have different diagnostic cause elements. Detik.com uses the word "and/or", then Republika.co.id uses the word "until". The use of the word and/or has three possibilities why Kece commits blasphemy. First, Kece intentionally blasphemed religion, Kece deliberately made hate speech related to SARA, and Kece deliberately committed blasphemy and hate speech related to SARA. Meanwhile, Republika.co.id uses the word "until" to indicate that Kece has intentionally and illegally committed hate speech and blasphemy.

Make a moral judgment on Detik.com news in the form of an assessment from Rusdi (Bareskrim) who suspects that Kece deliberately spreads information that triggers feelings of hatred and hostility. This can be seen in the fragment of the news text "Muhammad Kece is suspected of deliberately spreading information that can create feelings of hatred and hostility in society based on SARA"

Make moral judgment to Republika.co.id it was explained that Kece did his actions intentionally and illegally. This can be seen in the fragment of the news text "Based on the evidence, the investigator believes that it is strongly suspected that a criminal act has occurred, namely intentionally and illegally spreading information that can create feelings of hatred and hostility in the community."

The two media have different elements of making moral judgments. Detik.com uses indirect sentences, while Republika.co.id uses direct sentences. Sentences that imitate other people's words are direct so that their accuracy can be trusted by readers. While indirect sentences are sentences that are notified in their sentences based on someone's words(Khoirul Muslimin, 2021).

The treatment recommendations that Detik.com offers are confirmation that Muhammad Kece has been arrested and will be immediately detained. This is found in the news text, "It is known that Muhammad Kece was arrested at his hiding place, the police said that Kece would immediately be arrested."

In the Republika.co.id report, no treatment recommendation was found. This is because the author does not see the emphasis on problem-solving after Muhammad Kece has been arrested and the determination of the suspect. There has not been a continuation that has been described in the news, because no party has been written to explain what will be done next.

The difference between the two media in the Define problem element lies in the difference in the point of view of the two news stories. Detik.com views the Muhammad Kece case as a criminal act, but at Republika.co.id it is not only a criminal case but also a crime against Muslims. Republika.co.id has become very sensitive to issues related to Islamic teachings because Republika.co.id was born among Muslims.

The difference in the diagnostic cause element in the two media, Detik.com sees the source of the problem as Muhammad Kece's words being changed and distorted, while Republika.co.id sees the source of the problem because Muhammad Kece uploads content that is considered blasphemy against Islam. Republika.co.id not only sees a few words but also sees the whole video.

The difference in the elements of making a moral judgment in the two media lies in the point of view of the assessment of Muhammad Kece. Detik.com considers that the Kece case has an impact on the entire Indonesian community, while Republika.co.id considers that the Kece case has an impact on society as well, especially for Muslims in Indonesia.

The difference between the two media's Treatment recommendations, Detik.com emphasizes the overall solution, starting from the detention of the suspect to the actions taken regarding Muhammad Kece's videos. Meanwhile, Republika.co.id only emphasized the settlement of the alleged blasphemy case, which ended in the decision to arrest Muhammad Kece.

Conclusion

Based on the description above, it can be concluded that: (1) Detik.com and Republika.co.id have differences in constructing news of blasphemy by Muhammad Kece through the use of words,

sentences, and images to support news framing; (2) Detik.com constructs this blasphemy news in a soft form, considers this issue as a criminal act in general and does not judge before a decision is made by the authorities, while Republika.co.id constructs it in a firm form because it considers this issue as a criminal act as well as a crime against Islam and the content of the news tends to voice Muslims; (3) The difference in news framing in the two media can be seen from the differences in the four elements used in each news text.

The similarities between Detik.com and Republika.co.id in framing this religious blasphemy news are (1) Detik.com and Republika.co.id is both less balanced in the proportion of news; and (2) Both medias agreed that Muhammad Kece was guilty, was named a suspect and has been detained by the Police.
